We try to supply good quality puppies that represent their breed. Seller warrants that the above puppy comes with a current veterinarian health certificate. And is current on vaccinations and treated for parasites, worms, and pathological organisms. This is no guarantee that the puppy will build immunity to disease or be free of such.

Buyer has the right to have the puppy examined by a vet of their choice prior to purchase, at buyer's expense. If distance prohibits buyer from taking the puppy to the vet. Seller agrees to do so, at no charge within a 20 miles radius of seller's home. On-line buyers have been advised to view contract on-line or to get a copy prior to purchase. Let it be known acceptance of the puppy constitutes a signature and acceptance of the terms of this contract.

### Guarantee:

Under the following conditions:

1. 100% money back. If within 30 days the puppy dies of a genetic or congenial health defect. (i.e. heart, lungs, liver). Notice must be given within 24 hours of death. Along with a signed statement from a licensed veterinarian. Breeder reserves the right to have an autopsy before considering refund.
2. Replacement if: puppy is found to be affected with PRA. Optigen test results must be provided to breeder before 6 months of age.

This is the full extent, to all conditions, for cause for refund or replacement of said puppy.

Buyer is aware that the weight chart posted on our site is the one we use to determine adult size and weight. Buyer understands there is a risk, the puppy may not turn out the predicted size. We make no guarantee of size, weight, color, breeding or show quality, luxating Patellas, or Coccidiosis. Buyer is aware that tiny dogs are prone to luxating patellas and hypoglycemia.

Buyer professes that they are knowledgeable and committed to proper care, feeding, vet care, grooming, training, and precautions for a dog this size.

Buyer's assumes all responsibility and liability for care and condition of the puppy once it has left our premise, including but not limited to shipping. Any condition caused by carelessness or neglect, will void any guarantee.

Puppy must be spayed or neutered before adulthood. Seller did \_\_\_ or did not \_\_\_ retain AKC papers until proof of altering along with copy of this contract are provided to seller.

In the event the seller or breeder be required to retain legal services to enforce the terms of this contract. Buyer agrees to pay for the seller's or breeder's reasonable legal fees, court costs, plus reasonable interest, hereby incurred. This contract will be governed by the laws of Kentucky. All legal issues will be filed in the county of Nelson, State of Kentucky.

The undersigned has read, understands and agrees to abide by the terms and conditions herein. Furthermore the buyer will not hold the breeder or seller liable for anything outside the scope of this contract.
